DROPOSED AMENDMENTS TO THE CONSTITUTION SUBMITTED TO CITIZENS OF THIS COMMON-WEALTH FOR THEIR APPROVAL OR REJECTION, BY THE GENERAL AS-SEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA, AND PUBLISHED BY ORDER OF THE SECRETARY OF THE COMMONWEALTH, IN PUR-

A CONCURRENT RESOLUTION

Proposing an amendment to section twen-ty-six of article five of the Constitution of the Commonwealth of Pennsylvania. Resolved (if the Senate concur), That the following amendment to section twen-ty-six of article five of the Constitution of Pennsylvania be, and the same is here-

by, proposed, in accordance with the eighteenth article thereof:—
That section 25 of Article V., which reads as follows: "Section 25. All laws relating to courts shall be general and of uniform operation, and the organization, twisdiction, and powers of all courts of urisdiction, and powers of all courts of the same class or grade, so far as regu-lated by law, and the force and effect of the process and judgments of such courts. shall be uniform; and the General Assem-bly is hereby prohibited from creating other courts to exercise the powers vested by this Constitution in the judges of the Courts of Common Pleas and Orphans' Courts," be amended so that the same

shall read as follows:—
Section 25. Ill laws retaining to cour s shall be ger and of uniform operation, and the organization, jurisdiction, and powers of all courts of the same class or grade, so far as regulated by law, and the force and effect of the process and judgments of such courts, shall be uni-form; but, notwithstanding any provisions of this Constitution, the General Assembly shall have full power to estab-lish new courts, from time to time, as the same may be needed in any city or coun ty, and to prescribe the powers and ju-risdiction thereof, and to increase the number of judges in any courts now exsting or hereafter created, or to reorgan-ze the same, or to vest in other courts the jurisdiction theretofore exercised by courts not of record, and to abolish the same wherever it may be deemed neces-sary for the orderly and efficient adminis-

RESOLUTION Proposing an amendment to the Constitution of the Commonwealth of Penn-sylvania, so as to eliminate the requirement of payment of taxes as a qualifi-

cation of the right to vote.

Resolved (if the House of Representatives concur), That the following amendment to the Constitution of the Commonwealth of Pennsylvania be, and the same s hereby, proposed, in accordance with the eighteenth article thereof: That section one of article eight be amended, by striking out the fourth

numbered paragraph thereof, so that the said section shall read as follows: Section 1. Every male citizen twenty-Section 1. Every male citizen twentyone years of age, possessing the following qualifications, shall be entitled to
vote at all elections, subject however to
such laws requiring and regulating the
registration of electors as the General
Assembly may enact.

First. He shall have been a citizen of

the United States at least one month. Second. He shall have resided in the State one year (or if, having previously been a qualified elector or native-born citizen of the State, he shall have re-moved therefrom and returned, then six months), immediately preceding the elec-

Number Three A JOINT RESOLUTION Proposing an amendment to the Consti-tution of the Commonwealth of Pennsylvania, so as to consolidate the courts of common pleas of Allegheny

Section 1. Be it resolved by the Senate section I. Be it resolved by the Senate and House of Representatives of the Commonwess of Pennsylvania in General Assemble met. That the following amendment to the Constitution of Pennsylvania be, and the same is hereby, proposed, in accordance with the eighteenth

amended, by striking out the said sec-tion, and inserting in place thereof the following: Section 6. In the county of Philadel-

phia all the jurisdiction and powers now vested in the district courts and courts of common pleas, subject to such changes as may be made by this Constitution or by law, shall be in Philadelphia vested in five distinct and separate courts of equal and co-ordinate jurisdiction, composed of three judges each. The sald courts in Philadelphia shall be designated respectively as the court of common pleas num-ber one, number two, number three, number four, and number five, but the number of said courts may be by law increased, from time to time, and shall be in like manner designated by successive numbers. The number of judges in any of said courts, or in any county where the establishment of an additional court may be authorized by law, may be increased, from time to time, and whenever such increase shall amount in the whole to three, such three judges shall compose a distinct and separate court as aforesaid, which shall be numbered as aforesaid. In Philadelphia all suits shall be instituted in the said courts of common pleas without designating the num-ber of the said court, and the several courts shall distribute and apportion the business among them in such manner as shall be provided by rules of court, and each court, to which any suit shall be thus assigned, shall have exclusive juris-diction thereof, subject to change of venue, as shall be provided by law.

In the county of Allegheny all the jurisdiction and powers now vested in the several numbered courts of common pleas shall be yested in one court of com-mon pleas, composed of all the judges in commission in said courts. Such juris-diction and powers shall extend to all proceedings at law and in equity which shall have been instituted in the several suppliered courts and shall be subject to numbered courts, and shall be subject to aumbered courts, and shall be saide by law, and subject to change of venue as provided by law. The president judge of said court shall be selected as provided by law. The number of judges in said by law. The number of judges in said court may be by law increased from time to time. This amendment shall take effect on the first day of January succeeding its adoption.

Section I. He it resolved by the Senate and House of Representatives of the Com-monwealth of Pennsylvania in General Assembly met, That the following is pro posed as an amendment to the Constitu-tion of the Commonwealth of Pennsylvania, in accordance with the provisions of the eighteenth article thereof:— Amendment to Article Nine, Section

Eight. Section 2. Amend section eight, article nine, of the Constitution of Pennsylvania. which reads as follows:- "Section 8. The debt of any county,

other municipality or incorporated dis-trict, except as herein provided, shall nev-er exceed seven per centum upon the as-sessed value of the taxable property therein, nor shall any such municipality or district incur any new debt, or increase its indebtedness to an amount exceeding two per centum upon such assessed val-uation of property, without the assent of the electors thereof at a public election in such manner as shall be provided by law; but any city, the debt of which now ex-ceeds seven per centum of such assessed valuation, may be authorized by law to increase the same three per centum, in the aggregate, at any one time, upon such

valuation," so as to read as follows:— Section 8. The debt of any county, city, borough, township, school district, or oth-er municipality or incorporated district, except as herein provided, shall never ex-ceed seven per centum upon the assessed value of the taxable property therein, nor shall any such municipality or district in-cur any new debt, or increase its indebtdness to an amount exceeding two per centum upon such assessed valuation of property, without the assent of the elec-tors thereof at a public election in such manner as shall be provided by law; but any city, the debt of which now exceeds seven per centum of such assessed valuation, may be authorized by law to increase the same three per centum, in the aggregate, at any one time, upon such valuation, except that any debt or debts bereinafter incurred by the city and county of Philadelphia for the construction and development of subways for transit numbers, or for the construction of purposes, or for the construction of wharves and docks, or the reclamation of land to be used in the construction of a system of wharves and docks, as public improvements, owned or to be owned by sald city and county of Philadelphia, and which shall yield to the city and county of Philadelphia current net revenue in ex-cess of the interest on said debt or debts and of the annual installments necessary for the cancellation of said debt or debts, may be excluded in ascertaining the power of the city and county of Philadelphia to become otherwise indebted: Provided, That a sinking fund for their cancel shall be established and maintained.

JOHNSTONE WINS OUT

Goes Up 9.714 Feet, which Is the World's Record.

For the First Time in the History of Aviation the People in America Saw an Aeroplare Disappear from View in a Cloudless Sky - White Flew Faster Than a Mile a Minute, Winning a \$3,000 Purse.

New York, Nov. 1. - Ralph Johnstone, who has been flying a Wright biplane for the Wright brothers since last spring, yesterday afternoon brought the international aviation meet at Belmont park to a close by breaking the world's record for aeroplane altitude.

Johnstone climbed to a height of 2,714 feet or 528 feet higher than an aeroplane ever has been sailed before. Previous to Johnstone's world record climb, the world's record for altitude in an aeroplane was 9,186 feet. It was made at Mourmelon Le Grande, France, two months ago yesterday by Henri Wynman, a Dutch flier who, like Johnstone, also flies a biplane. Johnstone was in the air about one hour and a half, but all except the last few hundred feet of Johnstone's climb were

made during his first hour in the air. For the first time in the history of aviation America saw an aeroplane absolutely disappear from view in a cloudless zenith.

Johnstone Was Lost to View. While Johnstone was lost to view in the clear blue of the autumn sky over the center of the field, J. Armstrong Drexel climbed into the air in a monoplane, a 50-horsepower Bleriot, to take the grand altitude of the meet away from Jonhstone, Drexel ascended more than a mile and a half, but when he reached a height of 8,373 or 98 feet less than Johnstone flew last Thursday, an attack of sickness and the extreme cold told Drexel that he had

enough and he came down. Claude Grahame-White of the English team flew faster than a mile a minute in his 100-horsepower Bleriot in a special speed event and thereby

won a purse of \$3,000 for the event. "Johnstone was climbing all the time" said Wilbur Wright after Johnstone's feat, "and if he had had more experience with the machine he could have climbed the 286 feet more which would have given him the 10,000 food mark. The biplane will get that high, higher I hope, before long."

ENGLISHMEN GROWING TIMID

Are Investing Their Money Only In Timber Lands of British Columbia.

New York, Oct. 1, - Robert J. Wynne, who was American consulgeneral in London under Roosevelt's administrations and who is now in business over there as the representative of several American concerns, said today at the Wolcott that in London there is just now no business in American investments and the outlook

for such seems poor for the next year. "Outside of timberlands Englishmen are not putting money into American investments," said be. "And they are going into speculation in timber lands in Canada, particularly in British Columbia. They have made up their minds that there will be more or less of uncertainty in the United States. for at least a year, so far as business goes, and there will be a period of waiting to see what is going to hap-

Mr. Wynne was postive that in England Roosevelt is regarded as the greatest man in America. "The opinion over there seems set-

tle dthat the house will be Democratic." Mr. Wynne added, "though this is regarded as the inevitable reaction from tariff legislation and not charge able in any way to President Taft.

United States Bureau of Mines Has Constructed Six Cars for

Rescue Work. Washington, Nov. 1. - A lifesaving service for miners in time of disaster is about to be inaugurated by the United States bureau of mines. Six especially constructed cars, each manned by a corps of miners trained in rescue work and equipped with the latest rescue apparatus, will, within a few days, be located in the midst of the great coal districts of the country, These cars will be ready at a moment's notice to proceed to the scene of a disaster.

This is the first important step taker by the new bureau of mines in its efforts to reduce the great loss of life in American coal mines. In 1909 there were 2,412 miners killed in the coal mines and 7,979 injured. In the coal and metal mines it is estimated that 3,000 men were killed and 10,000 were injured in 1909.

For every 1,000 men employed, from 3 to 5 are killed each year in the mines of the United States. In foreign countries from 1 to 2 are killed in each 1, 000 employed. In those European countries where the deaths are least per 1,000 men employed, rescue apparatus has been in use for some time,

A general education will be carried on by the bureau among the miners, who will be taught not only the use of the rescue apparatus, but also the proper way to take care of an injured

A mining engineer and a surgeon of the American Red Cross will accompany each car and deliver illustrated lectures on the use of explosives, electrical equipment, fire prevention, sauitation and first aid surgical treatment.

GREAT GATES FOR PANAMA

They Will Be as High as a Six-Story

House and 65 Feet Wide. Pittsburg, Nov. 1.-Gates now being made for the Panama canal will be the largest in the world. Any one of the 92 of them-for there are to be 46 pairs in all-will be about as high as a six-story building, 65 feet wide and 7

feet deep or thick. The structural steel that will go to make them weigh 60,000 tons, or more than eight times as much as was used to build the Eifer Tower in Paris. The cost will be \$5,500,000. The thousands of individual pieces, numbered and fitted to go together as easily as children's blocks, will be shipped by steamer, and with them will go more than 400 skilled structural steel builders from Pittsburg to set them up. It will take three years to complete the

The location of the 46 pairs of gr will be: Twenty at the Gatun dam, on the Pacific side; twelve at Pedro Miguel, and fourteen at Miraflores, near the Atlantic entrance. The gates are designed to hold back water 47.4 feet

deep, in a channel 110 feet wide. Each lock will be ample for a ship 50 per cent larger than any vessel affoat, and it has been estimated that as many as a hundred ocean-going ships may be handled in a single day.
