

SUFFOCATED IN WELL

Victim Went Down In a 14-Fost Deep Oil Well In the Vicinity of the Vacuum Oil Company's Plant to Repair a Leakage In a Pipe When He Was Overcome by Fumes of Gas-Other Items of General Interest.

The second death within the last week from asphyxiation in the 14-foot dug oil wells in the vicinity of the Vacuum Oil company plant at Olean, N. Y., occurred Saturday.

The unfortunate man was Charles Fdwards, aged 39 years. He was employed by the Vacuum Oil company and went down into one of the wells to fix a pipe and was overcome by the gas.

The oll is supposed to come from the leakage of the big tanks and lines in the plant and soaks into the ground and stands in pools in the gravel. Mr. Edwards leaves a wife and child.

RAISE IN SALARY

Postmaster General Announces That Rural Mail Carriers Will Get

an Increase. Postmaster General Hitchcock at

Washington has just issued an order for the disbursement of \$4,000,000 in the current fircal year as increases in the salaries of rural letter carriers. This sum was appropriated for the purpose at the last session of congrees in terms that left it discretionary Over 2,000 household needs to with the postmaster general as to how much of it should be expended. Mr. Hitchcock had decided to anthorize the expenditure of the full amount. The effect will be to increase the ralaries of all rural carriers on standard routes from \$900 to \$1,000 a year with proportionate increases on the smaller routes.

On June 39 last there were 41.562 rural carriers and their aggregate salaries for the fiscal year just ended was about \$35,792,000. The rural delivery system was started only 15 year sago.

It increased from \$3 carriers at a cost of \$14,840 for the fincal year 1897 to 35,666 carriers at a cost of \$24,201,-520 for the fiscal year 1906. A large growth has also occurred in the last five years, the cost of the service having increased about \$10,000,000,

Death Valley Mystery Going East to Spend His Coin.

Death Valley Scotty, who has startled almost every large city in the United States by his eccentricities, turned up in Goldfield, Nev., Sunday with his pockets bulging with greenbacks. Three months ago Scotty was in Reno dead broke.

How he suddenly came into wealth is a mystery, but he displayed \$11,000 in currency and promised to reveal the location of his fabulous wealth after Aug. 1.

In the meantime Scotty says he intends making another spectacular whirlwind dash across the continent in a special train. After that Scotty will settle down.

"I have shot more champagne corks into the air than all the bullets fired in the Mexican war, and education has been expensive," he said. "I have learned enough and now 1 am going to look out for Scotty,"
