DEMOCRATIC GATHERING IN WAYNE.

The Democratic meeting at Bailey's Store in Wayne township, on Monday last, was largely attended, being of a two fold character—for township and county purposes.

Delegates were present from all the Divisions of the "Democratic Union" organized in the county, and while there was considerable difference of opinion concerning divers matters affecting the interest of the party, entire good feeling prevailed.

PITTSBURGH GENERAL MARKETS.

Flour—The market was dull, buyers fighting shy, and unwilling to invest unless at a decline in prices; to this sellers are not willing to assent, hence the operations have been restricted to lots to meet the wants of the local trade.—Among the sales we note as follows, viz: 300 bbls Extra \$6.30, 60; Extra Family, \$7.25, 50 per bbl. Also, sales of 200 bbls terms withheld. The receipts were limited.

Butter—The market was very firm, prices tending upward. The supply in first hands not being large we note sales of 1,800 lbs fresh roll that arrived by express, at 30c33c; sales of 400 lbs roll, prices ranging from 28c30c: 15 bbls at 28c30c.

Hay—The demand is selling off, and prices have a downward tendency.—Small sales were made at the scales at \$28.35. Sales of baled to a moderate extent at \$28.34 per ton.

Dried Fruit—The demand is increasing. Prices have an upward tendency, notwithstanding the increase of receipts. Sales 280 bush apples at \$2.80, 2.50 per bush. Peaches—Sales of 150 bush at \$3.25, 5.50 as per quality. The demand for export is steadily increasing.

Bacon—The market remains firm for all descriptions. The stock in this market is steadily disappearing. There was a fair business done in lots to meet the wants of the local trade. All good parcels brought the following figures: viz: Shoulders 9c; sides 11c; plain hams, 13c, some holders asking 13c; Sugar Cured hams, 14c; 14c. Sales of county meat at lower figures.

Lard—The demand was not active.—We quote nominally at 14c.

Potatoes—Prices are looking up; we note sales 200 bush at \$1.75, 2c.

Onions—Prices have advanced; we note sales 100 bush at \$1.75, 2c.
