Western Maryland Road

Obtains the Chief Engineer of the Western Maryland Railroad has recently prepared some plans for the purpose of explaining to the new members of the Board of Direction the prospective conceptions of the road and its requirements.

The demand is confined mostly to the wants of the home consumers, whose purchases foot up 500 barrels, including superfine at \$5.25@5.75, extras at \$6@6.25, Wisconsin extra family at \$7.25@7.50, Minnesota do. do. at \$7.75@8.25, Pennsylvania do. do. at 6.75@7.00, Indiana and Ohio do. do. at \$7@7.50, and fancy brands at \$7.50@8.50 as in quality. Rye is steady at \$6@6.12.

GRAIN.—The offerings of wheat are very moderate but fully ample for the demand which is limited, sales of 800 bushels Pennsylvania red at \$1.57@1.58, and 400 bushels Michigan white at \$1.72. Rye cannot be quoted at over 95 cents for Pennsylvania and western. Corn is quiet but steady; sales of old yellow at 80 cents, 2,600 bushels new do. at 70 cents, and 400 bushels old western mixed at 80 cents.
