EDITOR AGITATOR.—Sir: Every township in our county is at a loss to know how many men they have got for re-enlisted volunteers, and how they can find out. Herewith please find instruction that point, which if you please you might publish for the benefit of all concerned. I am Respectfully,

In order to ascertain whether a particular voter will be creditable to any township, it is necessary, the first thing to be done is to obtain from a Agent Gen. Bureau of Harisburg, a certified copy of his muster-roll. If you find that it sets forth his township, ward or borough to which the voter belongs, by name or by its number as a sub-district, no further action is required, and it will be established by the proper authorities at Washington, and it is carried through the regular channel. But it often occurs that the name of some village, post office, rail road station, or other local designation is given as his residence, and that there is nothing on the face of the rolls to show the township or sub-district in which he is situated and of which it forms a part. What is to be done in such cases? It is for you to direct to the District Provost Marshal, accompanied by what ever proof of the circumstances of the case may require, to enable him (the District Provost Marshal) to make up Supplementary re-muster rolls to supply the commission and correct the defect."
