SATURDAY MORNING, MARCH 14 1863. EXECUTIVE USURPATIONS. SPEECH OF HON. JOHN D. STILES, OF PENNSYLVANIA, IN THE HOUSE OF REPRESENTATIVES, February 18, 1863.

Mr. SPEAKER: At this late day in the session it requires all the impulse of duty to overcome my determination to allow the debate to close without mingling in this discussion.

The fifth and sixth articles of the amendments to the Constitution provide: "Art. 5. No person shall be held to answer for a capital or otherwise infamous crime, unless on a presentment or indictment of a grand jury, except in cases arising in the land or sea service in time of war or public danger; nor shall any person be subject for the same offense to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty or property without due process of law; nor shall private property be taken for public use without just compensation."

The second was a corollary of the first, and was intended to intimidate the people and compel obedience and support to the decree that the abolition of slavery was to be one of the objects for which the present war was to be prosecuted.

The President was elected by a popular minority, upon a platform which the people then believed you would carry out when you declared: "That the maintenance inviolate of the rights of the States, and especially the right of each State to order and control its own domestic institutions, according to its own judgment exclusively, is essential to that balance of power on which the perfection and endurance of our political fabric depends, and we denounce the lawless invasion by armed force of any State or territory, no matter under what pretext, as among the gravest of crimes."
