GENERAL Leaving Semperpari, on the Atchafalaya, where my command was at the date of my last dispatch, I landed at Bayou Sara at 2 o'clock on the morning of the 21st.

On the 23d a junction was effected with the advance of Maj. Gen. Angur and Brig. Gen. Sherman, our lines occupying the Bayou Sara road at a distance of five miles from Port Hudson.

On the 25th the enemy was compelled to abandon his position at the mouth of the Atchafalaya, which had covered our rear in the march from Alexandria, joined us on the 26th, and on the morning of the 27th a general assault was made upon the fortifications.

The assault opened fire between five and six o'clock, which was continued with unabated vigor during the day.

On the 28th the enemy's brigades, divided into two brigades, and the division of Gen. Emory, temporarily re-organized, commenced their operations under the command of Gen. Canby.

On the 29th the enemy's main body moved up to the fortifications, holding the opposite sides of the parapet with the enemy.

On the 30th our troops held their positions on the left, after dark, the main body being exposed to the fire of the enemy.

In the assault of the 31st, the behavior of the officers and men was most gallant, and left nothing to be desired. Our limited ammunition was used with the greatest economy.

On the extreme right of our line I posted the first and third regiments of negro troops, composed exclusively of colored men, excepting the officers, who were white.

Their conduct was most gallant, and they were distinguished by their valor and bravery in those to whom it was confined.

No troops could have more determinedly charged upon the batteries of the enemy, suffering very heavy losses, and holding their position against all the other troops on the right of our line.

On the 31st of this date, in killed, wounded and missing, nearly one thousand, including, I deeply regret to say, some of the ablest officers of the corps.
