Agriculture in this Country.

It appears from a published statement, that there were at the Chincha Islands, on the first day of August last, loading with guano for the United States, forty-four vessels, with an aggregate of 31,328 tons. | Catharine Miller, aged 2 years. There had sailed from the Islands, prior to August Ist, and not yet arrived, twenty-six Whitehall, Owen, son of Henry and Anna vessels, with 15.415 tons of guano on board. These vessels are all destined for the United States. A correspondent of the Charleston Mercury speaking of the demand for Peruvian guano for cotton, proposes that the United States government shall relieve Peru from its obligations to the British bondholders, under which the monopoly is maintained, by advancing to that government \$4,000,000 or \$6,000,000 on the condition that the guano trade shall be thrown open to this country; our importers paying the rates charged to the importers of other countries. The Washington Union copies the communication, with the remark that the "subject is attracting attention and provoking discussion in many of the Southern States, and we are sure the administration will not fail to give due consideration to the suggesvions made on the subject."----- It had been estimated that Upper Canada will have an amount of wheat, this year for exportation, exceeding that of any previous year, by four millions of bushels, valued at four million piasters, (\$3,500,000) ----- The first National Exhibition of imported blood and American breeds of horses is to be held at Springfield, Mass., on the 19th, 20th, 21st, and 22d, of October under the auspices of the U. S. Agricultural Society. The list of premiums to be awarded is on the most liberal Beeswax . . . scale, and will no doubt attract a very grate attendance from all parts of the country .--Provision is also being made to have a grand agricultural Binquet on the occasion, in order to have a good exhibition of men as wellas horses. 


