WILLIAM MONTGOMERY and LEONARD REBERT, Esquires, associate Judges in Columbia county, have issued their precept bearing date the 19th day of February in the year of our Lord one thousand eight hundred and thirty-eight, and to me directed for holding a Court of Oyer and Terminer and General Jail Delivery, General Quarter Sessions of the Peace, Common Pleas, and Orphan's Court,

IN DANVILLE, in the county of Columbia, on the third Monday of April next, (being the 16th day) and to continue one week.
