FLORIDA WAR.

Gen. A. McComb, who it will be recollected, was ordered sometime since to repair to Florida; and to negociate a peace with the Indians in that quarter, has written a letter to the Secretary of War, giving a detailed statement of his operations. He represents the Indians as having been auxious for peace, but desirous of remaining in that section of country for the present, but thinks there will be no difficulty in eventually persuading them to emigrate west of the Mississippi, as soon as they can be satisfied that their brethren who have already gone there, are favorably located. But for the present he has thought it advisable to conclude a treaty with them allowing them to remain within that territory. The following general order of Gen. McComb, embraces the substance of the treaty, the conditions of which he represents as having given general satisfaction to the Indians, and which he has no doubt will be faithfully kept on their part. Thus we hope this interminable war, which his cost the nation millions, has terminated.

GENERAL ORDER. Headquarters of the Army of the U. S. Fort King, Florida, May 18, 1839.

The Major-general-commanding-in-chief has the satisfaction of announcing to the army in Florida, to the authorities of the Territory, and to the citizens generally, that he has this day terminated the war with the Seminole Indians, by an agreement entered into with Chitto-Tustenugge, principal chief of the Seminoles, and successor to Ar-pi-eke, commonly called Sam Jones, brought to this port by Lieut, Col. Harney, of the 2d dragoons, from the southern part of the peninsula. The terms of the agreement are that the hostilities immediately cease between the parties; that the troops of the United States and the Seminole and Mickasukie chiefs and warriors, now at a distance, be made acquainted as soon as possible with the fact that peace exists, and that all hostilities are forthwith to cease on both sides; the Seminoles and Micassukies agreeing to retire into a district of country in Florida below Pesse creek, the boundaries of which are as follows viz: beginning at the most southern point of land between Charlotte harbor and the Colooshatchee river, at Sauybel Island; thence into Charlotte harbor by the southern pass between Pine Island and said point, along the east-ern shore of said harbor to Talak-Chopko or Pease creek; thence up that river to Hatchee Thloko or Big creek, thence up said creek to its source; thence easterly to the Northern point of lake Istopoga; thence along the eastern outlet of said lake, called Istopaga creek, to the Kissimme river; thence southwardly down the Kissimme to lake Oke-Chobee; thence south through said lake to Ecahlahatchee or Shark river; thence down said river westwardly to its mouth; thence along the sea shore northwardly to the place of beginning; that sixty days be allowed the Indians north and east of that boundary to remove their families and effects into said district, where they are to remain until further arrangements are made under the protection of the troops of the United States, who are to see that they be not molested by intruders, citizens, or foreigners, and that the said Indians do not pass the limits assigned them, except to visit the ports which will be hereafter indicated to them. All persons are therefore forbidden to enter the district assigned to said Indians, without written permission from some commanding officer of a military ALEX. MACOMB,

Major General Commanding in chief. By command of the General: E. Schriver, A. A. General.

After a trial of over four weeks, T. W. Dyett, of shin-plaster memory, has been convic ed of swindling, by a jury of his country. The penalty for the offence is from one to seven years imprisonment.

VIRGINIA ELECTION.

The returns from this state indicate the manner in which the battle has been fought, as the result shows that it has been closely contested. The majority of the Democrats in the Senate is four. The members of the House thus far elected are Democrats 61, Whigs and Conservatives 62. The remaining counties to be heard from stood last year 6 Democrats to 3 Federalists. The Richmond Enquirer says:-" We have already won the most brilliant victories; and we shall save the State from the Whigs and Conservatives. Mr. Rives' chance is gone. He cannot be re-elected Senatornor can a Whig. He is only half way in his difficulties."

So far as the Congressional returns have been received, 11 Democrats, 7 Federaltets and 2 Conservatives have been elected. In the remaining district a Democrat will undoubtedly be elected.
