Gems of the Inaugural.

The Inaugural Address of Mr. LINCOLN contains so many gems of thought, expression and logic, that they deserve a passing notice.

Gem the first: "Apprehension seems to exist among the people of the Southern States, that by the accession of a Republican Administration, their property, and their peace and personal security are to be endangered.

This is a slight improvement upon the declaration that there was "nothing the matter"—"nothing going wrong." It is ascertained that apprehension seems to exist—that it is barely possible the people of the Southern States entertain fears that their rights will be endangered under a Republican Administration.

"I therefore consider that, in view of the constitution and laws, the Union is unbroken, and, to the extent of my ability, I shall take care, as the Constitution expressly enjoins on me, that the laws of the Union be faithfully executed in all the States."

Here we are informed that the fact of secession is to be ignored, and that the laws of the Union are to be enforced in all the States.—Now, for the purpose of expounding and executing its laws in the States, the Government has instituted courts, appointed judges, marshals, &c., as its agents.

"Where hostility in any interior locality shall be so great and so universal as to prevent competent resident citizens from holding federal offices, there will be no attempt to force obnoxious strangers among the people for that object.

So it seems that the laws are only to be enforced to a certain extent in the disaffected States, while no attempt will be made to maintain the United States Courts, or to appoint federal officers to execute the laws in localities where universal hostility to the Government prevails.

"That there are persons in one section or another who seek to destroy the Union at all events, and are glad of any pretext to do it, I will neither affirm nor deny; but if there be such, I need address no word to them."

ACKNOWLEDGMENTS TO EX-SENATOR BIGLER.—We deem it to be an act of justice to Senator BIGLER, who has just completed his Senatorial term, to respond to the marked tribute of respect paid him by Senator CHITTENDEN of Ky at the late session of Congress. The venerable Kentuckian, according to the telegraphic report, devoted a portion of his final speech on the Compromise resolutions to a high compliment to Governor Bigler's untiring zeal in the cause of the Union.

DIFFERING FROM HIM, as we do on many of his party doctrines, we yet feel it to be an act of justice to extend to him, on his retiring from office, that meed of praise to which he is entitled.

PRESIDENT LINCOLN has nominated Cassius M. Clay, of Kentucky, Minister to Spain, and Thomas Corwin, of Ohio, Minister to Mexico. Both these nominations are made from the conservative or compromising division of the Republican party.

THE following resolution, complimentary to Hon. John J. Crittenden, was adopted by the Richmond convention, on Monday, by an almost unanimous vote: "Resolved, That the thanks of the people of Virginia be, and they are hereby, most cordially, tendered to Hon. John J. Crittenden, for his recent able, zealous, and patriotic efforts in the Senate of the United States to bring about a just and honorable adjustment of our national difficulties."

The tariff act of the southern confederacy has been made public, and goes into operation the 1st of May. As compared with the tariff of the United States, most of the articles paying 30 per cent, are reduced to 25 per cent, the larger portion of those paying 24 and 19 per cent, are reduced to 15. There is also a large 10 per cent, schedule, and a very small free list.

Bids for carrying the mails on nearly nine hundred routes in New York and in the New England States will be opened on the 31st instant. The annual cost of carrying the mails in those States, under existing contracts, is \$1,002,702 paid for the transportation of the mails over five thousand four hundred and forty-four miles of railroad.

GOLD AND SILVER deposited in the Franklin Saving Fund, No 130 South Fourth street, below Chestnut, Philadelphia, since January 1st, 1861, will be repaid in gold or silver. Bank notes deposited repaid in bank notes. Deposits received and payments made daily with interest.

The Georgia State convention, on Tuesday, transferred the forts, arms, arsenals, and munitions of war to the confederate States. An ordinance was passed appropriating \$500,000 to support the government, and authorizing the Governor to issue seven per cent bonds for that amount.

PAY OF OUR PEACE COMMISSIONERS.—The Legislature has appropriated \$4000 for the pay of our Commissioners to the Peace Conference. The original proposition was to give each member \$1000; the sum appropriated gives them \$571,43 each.

Delegations of the Choctaw and Chickasaw nations are now in Washington city for the transactions of business with the General Government.

In the Virginia convention yesterday Mr. Tyler spoke ably against the present congress propositions. Without concluding, the convention adjourned.
