THE RESULT.

Since the election the hot blood has flowed back from men's heads, and they talk again with reason and candor.

But it was a mistake in Governor Johnston to go before the people and make light of a solicitude for the peace of the community and the perpetuity of the republic.

Within less than a month elections in several states of the Union have turned upon the question whether there shall any longer be a Republic of the United States; and even in Pennsylvania while Johnston was ridiculing "all the little Union savers" a deliberative convention of steady sober citizens by resolution declared anew the old treasonable doctrine that the constitution of the American Union was a league with the powers of darkness in the nether world.

THE ELECTION.

The official returns of Philadelphia city and county show that for Senator Washington J. Jackson the Democratic candidate is defeated by Hamilton a half-breed Whig and Native.

For Judges of the District Court Stroul and Sharawood who were nominated by both parties are of course elected. J. Clark Hare, Whig, is elected over Findlay, Democrat, for the other Associate.

Wants War. The N. Y. Sun, on the authority of a private letter from Madrid, states that her august ladyship, the Queen of Spain, in a reply to a petition from a Cuban, for certain concessions to the ill governed island, said that she deeply regretted that she was not the mistress of her own desires, or she would at once declare war against the United States, come what might.

SOMETHING NEW UNDER THE SUN.—In a late number of the Cherokee Advocate, there is published an order from Col. J. Drennen, the Superintendent of Indian Affairs, requiring all white persons residing in the Cherokee Nation, west of the State of Arkansas, to leave within thirty days of the 28th ult., "except regularly licensed traders and the employes mentioned in their licenses, granted them by the Agent of the United States, and such others as may be regularly married to Cherokees, and who maintain a fair character for sobriety, industry and morality, and deport themselves in all respects in accordance with the intercourse law of the United States."

THE CHURCH OF ENGLAND.—Twenty-six new bishoprics are to be created in the English Church. This will give a total of fifty-four,—the bishops receiving an annual aggregate income of about £185,000.
