OF PUBLIC DEBTS.

OF PUBLIC DEBTS. Szc. 1. The state may contract debts, to empty casual deficits or failners in reve-nue, or to neet expenses not otherwise pro-vided for; but the aggregate smouth of such debts direct and contingent, whether con-tracted by virtue of one or more acts of the general arsembly, or at different periods of time, shall never exceed seven hundred and fifty thousand dollars, and the money aris-ing from the creation of such debts, shall be applied to the purpose for which it was ob-tained, or to repay the debts so contracted, and to no other purpose whatever.

To provide for the psyment of the present debt, and any additional debt con-tracted as aforesaid, the legislature shall, at its first session, after the adoption of this amendanent, create a sinking fund, which shall be sufficient to ray the accruing in-terest on such debt, and annually to reduce the principal thereof by a sam not less than two hundred and flig thousand dollars; which sinking fund shall consist of the net annual income of the subtle works, from time to time owned by the state, or the pro-ceeds of the sale of the same, or any par thereof, and of the income or proceeds of sale of stocks owned by the state, together with other funds, or resources, that may be designated by law. The said sinking fund may be increased, from ture to time, by as-signing to it any part of the taxes, or other ordinary and current expenses of Govern-ment, and unless in case of war, invasion or insurrection, no part of the said sinking fund shall be used or applied otherwise than in extinguisment of the public debt, until the amount of such debt is reduced below the sum of five millions of dollars. The credit of the commonwealth shall not in any manner, or even, be pledg ed, or loaned to, any individual, company, corporation, or association; nor shall the commonwealth hereafter broome a joint owner, or stockholder, in any company, as-sociation, or corporation. amendment? 
