ARTICLE XI.

OF PUBLIC DEBTS.

SEC. 1. The state may contract debts, to supply casual deficits or failurers in revenues, or to neet expenses not otherwise provided for; but the aggregate amount of such debts direct and contingent, whether contracted by virtue of one or more acts of the general seaembly, or at different periods of time, shall never exceed seven hundred and filty thousand dollars, and the money arising from the creation of such debts, thall be applied to the purpose for which it was obtained, or to repay the debts so contracted, and to no other purpose whitever.

SEC. 2. Ir addition to the above himited power the state may contract debts to repel invasion, suppress insurrection, defend the state in war, or to redeem the present outstanding indebteshess of the state; but the money arising from the contracting of such debts, shall be applied to the purpose for which it was raised, or to repay such debts, and to no other purpose whatever.

SEC. 3. Except the debts above specified, in sections one and two of this article, no debt whatever shall be created by, or on behalf of the state.

SEC. 4. To provide for the payment of the present debt, and any additional debt contracted as aforesaid, the legislature shall, at its first session, after the adoption of this ammendment, create a sinking fund, which shall be sufficient to ray the accuring interest on such debt, and annually to reduce the principal thereof by a sum not less than two hundred and filty thousand dollars; which sinking fund shall consist of the net annual income of the public works, from time to time owned by the state, together with other funds, or resources, that may be designated by law. The said sinking fund shall be used or applied otherwise than in extinguishment of the public debt, until the amount of such debt is reduced below the sum of fise millions of dollars.

SEC. 5. The credit of the commonwealth shall not in any manner, or event, be pledg d, or loaned to, any i

SEC. 6. The commonwealth shall not assume the debt, or any part thereof, of any county, eity, borough, or township; or of any corporation, or association; unless such debt shall have been contracted to enable the state to repel invasion, suppress domestic insurrection, defend itself in time of war, or to assist the state in the discharge of any portion of its present indebtedness.

SEC. 7. The legislature shall not authorize any convey city, burough, township, or in

citizens, or otherwise, to become a slock-holder in any company, association, or cor-poration; or to obtain money for, or loan its credit to any corporation, association, insti-tution, or party.
