SERIOUS ACCIDENT .- We learn, from a reliable source, that a horse and wagon was run over at the crossing of the Cattawissa out interruption or adjournment, until 7 Railroad, at McKelvy's Mills, near Catawissa, this county, on Saturday last. Mr. Jacob Yesger, a merchant at Slabtown, and a son of Charles Strauser, of Catawissa, were badly injured ; they were thrown a distance of thirty feet in the Cattle Guard. The young man's head was badly cut, and otherwise injured. The wagon was ground up fine enough for kindling-wood. 
