The Wilkesbarre Record announces that Rev. Thomas P. Hunt has been appointed Chaplain of the 2d Pennsylvania Artillery, Col. A. A. Gibson, stationed at Fort Lincoln, near Washington. Mr. Hunt is a kind old man. He was Chaplain in the 17th Regiment, last summer, of which we were a member.

HON. JOHN McREYNOLDS, one of the Associate Judges, had sufficiently recovered from the injuries sustained by falling upon the ice and dislocating his shoulder, as to be able to attend to the duties of his office at Court last week. The citizens of Bloom township held a meeting in the Court House on Monday evening last, for the purpose of taking steps towards raising a bounty for volunteers, to fill the quota of this township, which is about forty-three men. The meeting was well attended, and a pretty good sum of money was raised by subscription, with few exceptions, from those subject to draft. After this was done, it was proposed to subdivide the district, and Committees were appointed to visit those subject to draft and ascertain what amount of money could be raised. The object is to clear the township from draft by hearing volunteers, which some of our citizens feel very sanguine can be done. The Committees were to report on Tuesday evening last. We are not advised as to the result.
