SECTION 1.

PROCLAMATION

WHEREAS, in and by the Act of the General Assembly of this State, entitled, "An Act to regulate the General Elections of this Commonwealth," enacted on the 2d day of July, 1856, it is enjoined on me to give Public Notice of such Election to be held, and to convene in such election, in and by the Act of the General Assembly, at the County of Adams, do, therefore, hereby give this Public Notice to the Electors of the said County of Adams, that a

GENERAL ELECTION

will be held in said County, on the Tuesday of October next, (the 14th), in the several Districts composed of the following Townships, viz:

In the First District, composed of the Borough of Gettysburg and the township of Cumberland, at the Court-House in Gettysburg.

In the Second District, composed of the township of Germany, at the house now occupied by Levi Kreps, in the town of Littletown, in the township of Germany.

In the Third District, composed of the township of Oxford, at the house of Widow Milcy, in the town of New Oxford.

In the Fourth District, composed of the townships of Lantmore and Huntington, at the house of Caleb B. Hildebrand, in the township of Huntington.

In the Fifth District, composed of the townships of Hamilton and Liberty, at the Public School-house in Millersboro.

In the Sixth District, composed of the township of Hamilton, at the house now occupied by David Newcomer, in the town of East Berlin.

In the Seventh District, composed of the township of Menallen, in the public School-house in the town of Beaderville.

In the Eighth District, composed of the township of Straban, at the house of Jacob L. Grass, in Hunterstown.

In the Ninth District, composed of the township of Franklin, at the house formerly occupied by Jacob Sallsworth, in said township.

In the Tenth District, composed of the township of Conowingo, at the house of John Bauser, in Meadsboro.

In the Eleventh District, composed of the township of Tyrone, at the house of Samuel Sadler, in Helderberg.

In the Twelfth District, composed of the township of Mounjany, at the house of Geo. Snyder, in said township.

In the Thirteenth District, composed of the township of Mount Pleasant, at the public School-house in said township, situate at the cross roads, the one leading from Oxford to the Two Taverns, the other from Hunterstown to Elsmere.

In the Fourteenth District, composed of the township of Reading, at the public School-house in Hampton.

In the Fifteenth District, composed of the Borough and township of Horshelm, at the public School-house in Abbotstown.

In the Sixteenth District, composed of the township of Freedom, at the house of Nicholas Moritz, in said township.

In the Seventeenth District, composed of the township of Union, at the house of Ruch Lefever, in said township.

In the Eighteenth District, composed of the township of Butler, at the public School house in Middletown, in said township.

At which time and places will be elected

One Auditor General of the Commonwealth;

One Surveyor General;

One Canal Commissioner;

One Member of Congress, to represent the District composed of the Counties of Adams, Franklin, Bedford, Fulton, and Juniata;

One Member of State Senate, to represent the Counties of Adams and Franklin;

One Member of Assembly, for Adams county;

Two Associate Judges;

One Commissioner;

One Auditor;

One Director of the Poor;

One District Attorney; and

One County Surveyor.

Particular attention is directed to the Act of Assembly, passed the 27th day of February, 1849, entitled "An Act relative to voting at elections in Adams, Dauphin, York, Lancaster, Cumberland, Bradford, Centre, Greener, and Erie counties, and in the Borough and townships of Adams, in the Commonwealth of Pennsylvania in General Assembly," and it is hereby enacted by the authority of the same—that it shall be lawful for the qualified voters of the counties of Adams, Lancaster, Dauphin, York, Franklin, Cumberland, Bradford, Centre, Greener, and Erie, from and after the passage of this act, to vote for all candidates for the various offices to be filled at an election on one slip or ticket: Provided, That the office for which every candidate is voted for, shall be designated, as required by the existing laws of this Commonwealth.

SECTION 2. That any fraud committed by any person writing in the manner above prescribed, shall be punished by the existing laws of this Commonwealth.

Also—In and by virtue of the 14th section of the act aforesaid, every person, excepting Justice of the Peace, who shall hold any office or appointment of profit or trust under the Government of the United States, or of any city or incorporated district, whether a commissioned officer or otherwise, a subordinate officer or agent, or shall be employed under the legislative, executive or judiciary department of this State, or of the United States, or of any city or incorporated district, and also that every member of Congress and of the State Legislature, and of the Select or Common Council of any City, or Commissioner of any Incorporation, shall be incapable of holding or exercising at the same time, the office or appointment of Judge, Inspector, or Clerk of any election of this Commonwealth, and that no Judge, Inspector, or other officer of any election, shall be eligible to any office to be then voted for.

Also—That in the fourth section of the Act of Assembly entitled "An Act relating to executors, and for other purposes," approved April 10th, 1840, it is enacted that the aforesaid 18th section "shall not be construed, as to prevent any militia officer or burgoon, from serving as judge, inspector or clerk, at any general or special election in this Commonwealth."
