Beginning at 11 o'clock yesterday morning the new automatic signal service of the Pennsylvania railroad between Lewistown Junction and Den-holm was placed in service. This im-provement adds ten more miles of automatic protection to the middle di-vision, and leaves but one section un-der the old system lying between Lew-istown Junction and Huntingdon a distance of thirty-eight miles. The placing of the new automatic signal system in service yesterday will necessitate big changes in the towers as the automatic signals will cut down the number of operators needed. D. J. Markel, of Lewistown, will have charge of the new system for the present. The older men will be given preference in assignment to duty in the new tower and will work on eight-hour trick. Four block signal towers will be firminated and the work of the en-tire section will be done in the one tower. The automatic signals have proven a big success along the main line of the Pransy and wherever it is adopted. Trains passing certain points will operate the signals, and when the signals are not working right, notice will be given the men in the tower who will stop all trains until the signals are in working or-der.
