Philadelphia Physician Thinks Paris Green Caused Floyd Keller's Death

Chambersburg, Pa., May 1.—Taking of evidence in the case of trial of Mrs. Zeldia Keller Gerhold, who is accused of having caused the death of her husband, Floyd Keller, by poisoning, was continued yesterday.

The critical condition of Keller led Dr. Kinter to call Dr. W. F. Skinner, of Chambersburg, for a consultation and after Keller's death both the physician and the chemist, Dr. Kinter, in which the cause of his death was stated as puerperal hemorrhages.
