



Has Just Been Launched

London, Oct. 27, A. M.—A dis-patch from Geneva, Switzerland, to the Express gives this account of the launching of a new Zeppelin: "The most powerful Zeppelin yet made has just been launched at Freiderichhaven on Lake Constance. Without preliminary trials it flew away northwards at great speed, cheered by the soldiers who shouted "To London!" Count Zeppelin was present at the launching. "The airship has a special armored compariment for bombs near her pro-pellers and her gun is mounted in front to destroy aeroplanes. A second airship of a similar type will be ready by the end of October.
