## SUSOUEHANNA RIVER **GETS BRUNT OF STORM**

[Continued from First Page.]

Eastern Michigan yesterday morning caused a precipitation over Pennsylvania probably amounting to an average of about one and one-half inches; however, no streams of the State, excepting those in the Susquehanna drainage basin, were materially affected by this rainfall.

"In the Susquehanna basin, a maximum stage of eighteen and one-half feet is indicated for the west branch at Williamsport; on the north branch, a stage of about seventeen and one-half feet for Towanda, twenty-five feet for Wilkes-Barre and twenty feet for Danville; fourteen feet for Newport on the Juniata, and probably about seventeen feet for Harrisburg on Friday afternoon.
