During the conference sessions committee reports will be given on Sunday school work, temperance, home missions, church erection, nominations, Young People's Society of Christian Workers, Lebanon Valley College, organization of the State or county, education, lay delegates, conference publications, missions and church extensions, resolutions and the Mount Greta sessions.

Conference statistics given last year broke many records and it is expected that another record year will be reported from the churches included. A fourteenth convention in September, at the close of the conference year in 1914 there were 149 churches organized with a total membership of 78,731. These churches included 45 Sunday schools and 106 young people's societies. The officers and scholars in these Sunday schools and societies also totaled many thousands.
