New York, June 3.—The week-end session denoted the concern of financial interests in the latest news from abroad. International shares were inclined to sag for the most part, with concessions in Anglo-French and Canadian war issues.

Speculation in certain specialties was renewed with greater vigor, however, automobile stocks adding enormously to recent gains, with new high records for Willys-Cverland common and preferred and Chandler Motors, while General Motors made a jump of 67 points at 529. Cuban and South Porto Rico sugars rose 14 to 15 points and Marine preferred came within the smallest fraction of its maximum at 98 %. The closing was irregular. Bonds were lower.
