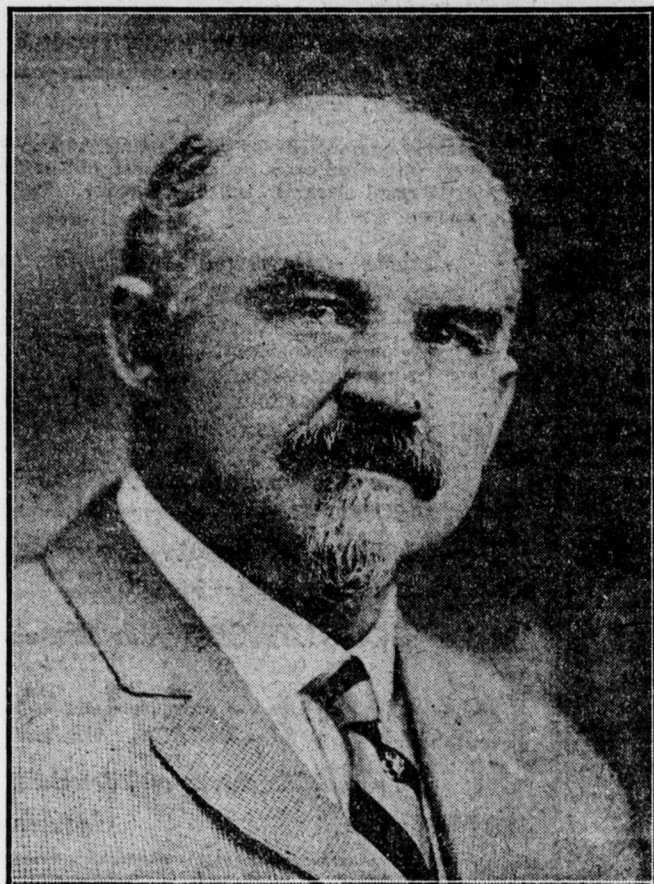


# The Republican Ticket in Dauphin County

Men whose only pledge if elected is that they will fulfil their duties honestly and faithfully, with due regard for the wishes and opinions of their constituents.

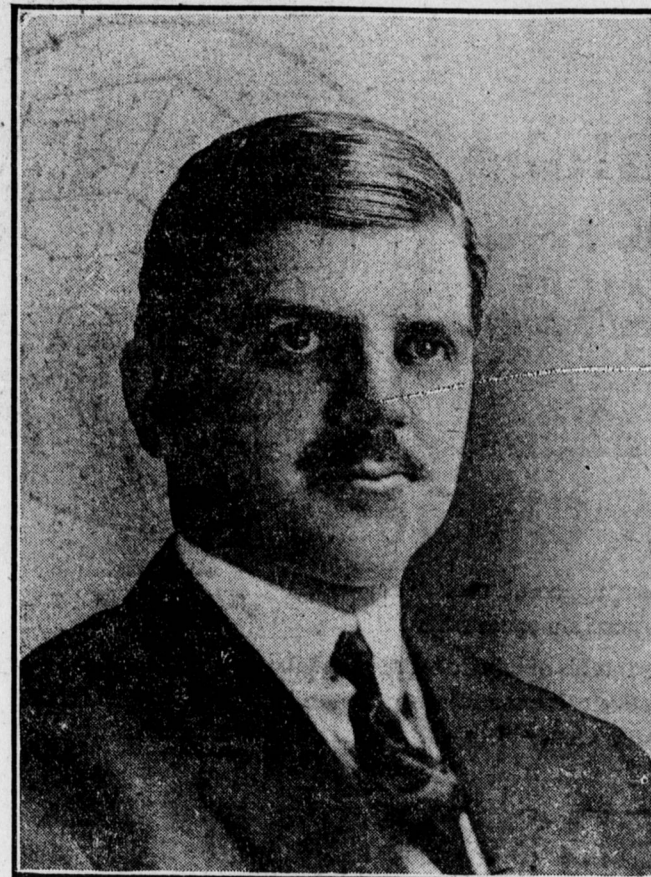
## FOR CONGRESS



**Aaron S. Kreider**

Congressman Aaron S. Kreider, of Anville, Lebanon county, is a candidate for re-election. **E. E. Beidleman**

Senator E. E. Beidleman, candidate for re-election to the State Senate, is a Dauphin countian, born and bred. He is one of the best-known lawyers in Pennsylvania and is now president pro tempore of the Senate, a position not held by any Dauphin county member since the days when Judge McCarrell represented this district in that body. Mr. Beidleman was a poor boy. He was graduated with honor from the Harrisburg High School and afterward studied law under Hon. S. J. M. McCarrell, now additional law judge of Dauphin county. He has served two terms in the Legislature and one term in the Senate. His legislative career has been remarkable for his activities in behalf of labor legislation. He was the champion of many bills advocated by the Mine Workers of America and has represented the Railroad Brotherhoods in some of the most important cases ever brought in the Dauphin county courts attacking the constitutionality of labor laws. His record in the Legislature is absolutely clean. His vote is registered on the right side of every big question that has come up in recent years. Senator Beidleman is an eloquent speaker and a parliamentarian of ability. He was elected president pro temp. of the Senate because of his eminent qualifications. Senator Beidleman's only pre-election promise is that he will do his full duty, honestly and conscientiously, for the welfare of a majority of his constituents and, so far as possible, in accord with their wishes.

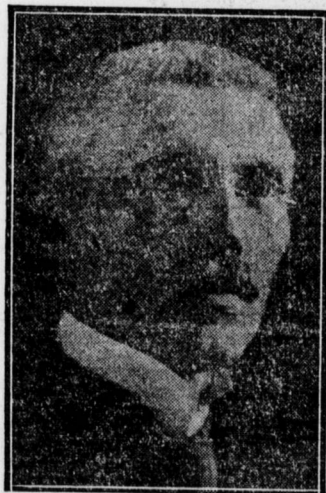

## NOMINEES FOR THE LEGISLATURE

### First District



**Augustus Wildman**

Augustus Wildman, Republican candidate for the Legislature in the First district, was born in Germany in 1856, and emigrated to this country six years later. He was educated in the public schools and in 1885 removed to Harrisburg from Gettysburg. He learned the barber trade and in 1893 engaged in the contracting and building business which he has successfully followed since that time. He served as a member of the common and select branches of Harrisburg City Councils, resigning from the latter branch upon his election to the House of Representatives in 1912. He was re-elected in November, 1914, and served on a number of important committees.



**Joshua W. Swartz**

Joshua W. Swartz, Republican candidate for the Legislature in the First district, was born on a farm in Lower Swatara township, Dauphin county, June 9, 1867. He was graduated from the Dickinson School of Law in 1892, and was admitted to the bar of Dauphin county on July 12, 1892, since which time he has been engaged in the practice of his profession. He was elected to the House of Representatives in November, 1914, and was re-nominated last May. He is a well-known lawyer and stands for re-election on his record in the Legislature.

### For Mine Inspector Charles J. Price

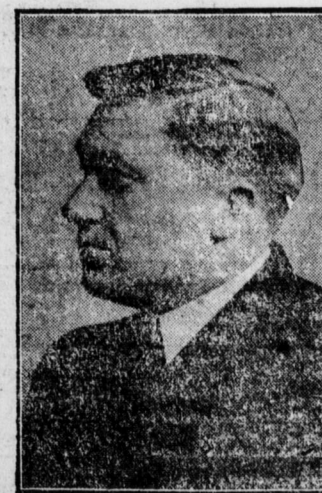

### Second District



**Ira E. Ulsh**

Ira E. Ulsh, of Millersburg, Republican nominee for the Legislature in the county district, is a self-made man. He was born in Beaver Springs, Snyder county, but has spent the past twenty years as a resident of the upper end of Dauphin county, where he is well and favorably known. For upward of 20 years he has been engaged in mercantile business, a part of the time as a warehouse operator and later in the flouring industry. He has never held any public office, but has been a lifelong Republican and always interested in public affairs. The nomination came to him unsolicited as a result of the urging of his neighbors that he submit his name as a candidate. Mr. Ulsh will be remembered as the man who, through the Mine Workers of America, supplied all the flour used by the coal miners of the Ninth district during the strike of 1902. Mr. Ulsh was educated in the public schools and is a graduate of Freeburg Academy. He is a business man of recognized ability and those who know him best say he will make an excellent legislator.



**David J. Bechtold**

David J. Bechtold, Republican nominee for the Legislature, is a resident of Steelton and is billing clerk in the bridge department of the Bethlehem Steel Works. He was born in Lebanon county and educated in the public schools. He cast his first ballot in Steelton where he has been a resident ever since. He entered the service of the old Pennsylvania Steel Company as an office boy and worked his way to his present position. He has been always active in borough affairs and has served as borough auditor. He is a member of the Knights of Pythias, the Independent Order of Americans and president of the Citizen Fire Company, the oldest organization in Steelton. Mr. Bechtold has been long prominent in athletics and was assistant manager of the Y. M. C. A. football team when it was one of the best in the State. He is well known among the working men of the big plant.
