

Vernander, former assistant minthe conduct of the war, General A. P. Vernander, formér assistant min-ister of war, declared yesterday at the trial of General Soukhomlinoff for high treason. The war minis-ter, General Vernander said, pund no heed to the equipment of the army and gave no contracts to workshops and factories which manufactured munitions; as a re-suit he testified the munition pro-duction progressed haltingly and after 130 days of war the Russian army was without shells. General Vernander succeeded General Souk homlinoff temporarily as minister of war.
