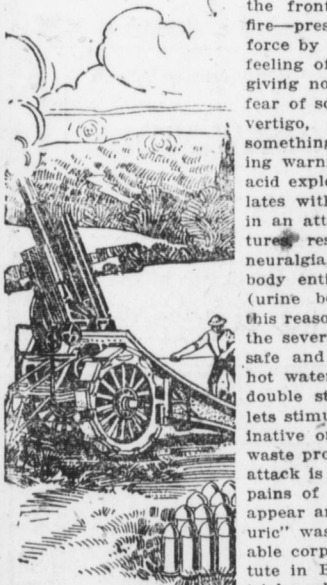

The opinion is the latest in a series issued by the legal department in construing the new dog law and specifically sets forth the duties of officers, who are required to enforce the act and also provides that only the officers named are entitled to the fees for rounding up, detaining or killing dogs. State policemen and wardens of various departments or commissions may be called upon to help. "Any person who refuses or neglects to perform his official duties violates this law or any person who fails or refuses to comply with its provisions is likewise guilty of its violation," holds the opinion. This applies, it is stated, to any one from a county commissioner or treasurer to a police officer. As the State is making an effort to increase sheep on farms in Pennsylvania, the law is to be strictly enforced it is stated by Mr. Patton. An interesting feature in connection with the act is that Attorney General Brown has been asked by county authorities in Maryland and Delaware for copies of the act for study of its possible application to conditions in their communities. Pay Big Tax—Hundreds of thousands of dollars are being paid into the State Treasury by the banks and trust companies of Pennsylvania under the "State bank tax act" as the time for the exemption on securities held will expire on March 1. Under the law national and state banks pay four mills and trust companies five mills. If they pay before March 1, they do not pay on bonds or mortgages. The majority take advantage of the exemption.
