

measure sponsored by Senator The Valley Forge appropriation A measure sponsored by Senator Daix, Philadelphia, would create a new Department of Motor Vehicles, under the direction of a commission-er of Motor Vehicles, at \$5,000 per year and various subordinates. This department would have complete control of the regulation of vehicles, and of electric street cars. If the bill passes, more than a dozen new state jobs will be created, to com-prise the new department. Senator Woodward, Philadelphia, presented a measure creating a homestead commission, whose duties would be to devise means whereby persons of small means could secure small houses and garden plots near the large cities. The members of bill carrying \$250,000 was reported to the House with the bill to pro-vide compensation for injured State mployes. The report of the State Insurance Code Commission was presented, and


