Half of Deaths Among American Soldiers in England Due to Flu

London, March 31.—More than half the deaths among the American soldiers in Great Britain were due to influenza. The total number of cases of the disease in the three months from February 1, among the Americans here reached 7,512. In that period deaths from pneumonia, developing in most cases from influenza, numbered 1,717. Of 6,000 troops from the United States, the steamer Olympic, 2,000 contracted the disease and, as about one-third of these cases developed pneumonia, the proportion of fatalities was very large.
