

REVISED COVENANT OF THE LEAGUE OF NATIONS IS BEFORE PEACE CONFERENCE

What Action Will Be Taken Is Unknown ADJUSTMENTS MUST BE MADE

Paris, April 28.—The revised covenant of the League of Nations, which was made public in the United States this morning, is before a plenary session of the Peace Conference to-day for final action.

The French amendments were designed to reinforce French military security, but these may not be pressed owing to the military security which France obtains under the settlement of the Rhine frontier.

The Japanese delegates have not yet indicated whether they will renew their amendment on racial equality, as that depends somewhat on the settlement which are to be secured concerning Korea.

The Monroe doctrine amendment is not expected to encounter opposition if the question of French security is adjusted.

The word "external" in Article 19, according to the analysis shows that the league cannot be used like the Holy Alliance to suppress national or other movements within the boundaries of member states, but only to prevent forcible annexation from without.

Washington, April 28.—The revised covenant of the League of Nations, as it will be presented at Paris to-day to the Peace Conference in plenary session, includes important amendments designed to meet criticisms in the United States of the original draft.

31 States Named Attached to the text, however, is the hitherto unpublished "annex" referred to in the covenant, in which are named the thirty-one states, including the self-governing British dominions, which are to be the original members of the League of Nations.

Mexico Is Out Mexico was not represented in the conference of neutrals at Paris, and, as was expected, does not appear in the list.

Publication of the text discloses that the official summary quoted regarding the new article recognizing the Monroe doctrine. It provides that nothing in the covenant shall be deemed "to affect the validity of international engagements such as treaties of arbitration or regional understandings like the Monroe doctrine for securing the maintenance of peace."

REVISED COVENANT OF LEAGUE OF NATIONS

THE TEXT of the revised covenant of the League of Nations, being considered in Paris to-day, follows with parenthetical insertions showing changes made in the covenant as originally drafted:

In order to promote international co-operation and to achieve international peace and security, by the acceptance of obligations not to resort to war, by the prescription of just and honorable relations between nations, by the firm establishment of the understandings of international law as to actual rules of conduct among governments, and by the maintenance of justice and a scrupulous respect for all treaty obligations in the dealings of organized peoples with one another, the contracting parties agree to this Covenant of the League of Nations.

Article One. The original members of the League of Nations shall be those of the signatories who are named in the annex to this covenant and also such of the other states named in the annex as shall accede without reservation to this covenant.

Article Three. The assembly shall consist of representatives of the original members of the League of Nations, and also of representatives of such of the other states named in the annex as shall accede without reservation to this covenant.

Article Four. The council shall consist of representatives of the original members of the League of Nations, and also of representatives of such of the other states named in the annex as shall accede without reservation to this covenant.

Article Five. Except where otherwise expressly provided in this covenant, all matters of procedure at meetings of the Assembly or of the Council shall be regulated by the rules of procedure of the League of Nations.

Article Six. The permanent secretariat shall be established at the seat of the League of Nations. The secretary general shall be appointed by the Council with the approval of the majority of the Assembly.

Article Seven. The seat of the League of Nations shall be established at Geneva.

Article Eight. The members of the League of Nations shall be equal in rights and responsibilities. They shall be bound to fulfill in good faith the obligations assumed by them in accordance with the provisions of this Covenant.

The members of the League agree that they will carry out in full good faith an award that may be rendered and that they will not resort to war against a member of the League which complies therewith.

Article Fourteen. Virtually unchanged. Article Fifteen. To Investigate Disputes. If there should arise between two or more members any dispute likely to lead to a rupture, which is not submitted to arbitration as above, the members of the League agree that they will submit the dispute to the Council.

Article Sixteen. The council shall be composed of representatives of the original members of the League of Nations, and also of representatives of such of the other states named in the annex as shall accede without reservation to this covenant.

Article Seventeen. The council shall be bound to fulfill in good faith the obligations assumed by them in accordance with the provisions of this Covenant.

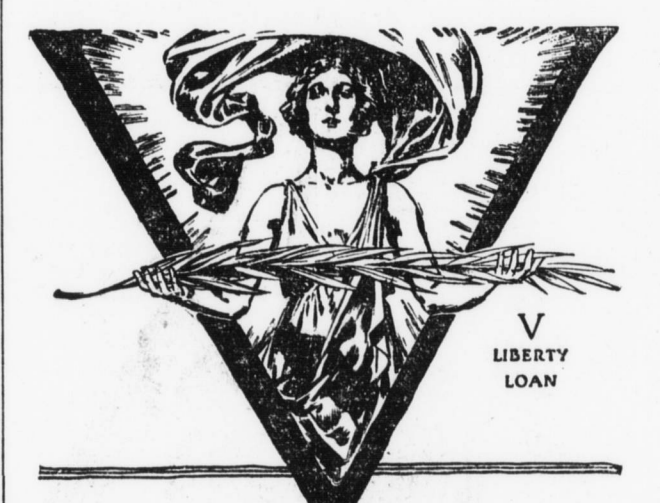
