DRIVE PLANNED

Miss Julia Stamm is Home Campaign for Ten Thousand Dollars for Two Institutions Begins Monday

When Miss Julia Stamm Montgomery Stamm was asked this morning to tell something about her experiences in Y. M. C. A. canteen work in France, she modestly said nothing thrilling, and came her way to the canteen work had much good, hard work to do, and she did it as bravely as the men.

Miss Stamm arrived at her home, Thirteenth Street and Chestnut, yesterday, after landing in New York with the passengers of the Graf Waldersee on Monday, carrying 4996 troops with the European Expeditionary Force. She has a Y. M. C. A. head on board, but Miss Stamm was the only canteen worker on this boat, although there were many nurses returning. Each day, she assisted in serving candy, chocolate, chewing gum and cigarettes to the men, arranging the sing-song and Sunday services, etc. The Red Cross had a representative on the boat, also.

Miss Stamm started abroad last November. Just after the armistice was signed, and was first stationed with the Y. M. C. A. canteen in England, going to the Riviera later and then to the front. She had a long leave early work. She has had a wonderful experience for the historic old Casino in Cannes, the exclusive gambling place where the Riviera has to harbor men from all countries and ranks in life after years and years of visits from only the wealthy and great.

As Base Hospital No. 93—really three hospitals—was in Cannes, the soldiers just lived at the Y. M. C. A. headquarters. Miss Stamm, who had come thoroughly acquainted with many of them, Miss Stamm says the girls were on duty as in hotel shifts, and the canteen was open from 10:30 to 12:30, and then from 2:30 to 4:30. She was Sunday afternoon parties when the refreshments were free and other diversions.

One great pleasure was the picnics for the boys, going out in the country in trucks and trams for a real holiday. The Y. M. C. A. furnished the cars and there were games, concerts and reading places just like a big school picnic.

Only Kindly Criticism - When asked her own view of the Y. M. C. A. work in France, Miss Stamm said: "Of course, I know personally only of the leave area section; there it has done a marvelous work, and I think you'll find that the Y. M. C. A. claim is only of isolated cases, which will persist in clinging to one's memory. Many of the boys, themselves, who wrote home, and the girls, who felt were unjust as found in the camp life, told their home folks later, when they had become adjusted to conditions and had experienced the care and generosity of the Y. M. C. A. in this leave area that 'everything is done for us, and nothing is too much trouble.' They were sent to Cannes and the Riviera will give a glowing account of their reception and treatment."

The days were filled with hard work with now and then a trip to some special place of interest. The people of Cannes, wealthy Americans, English and French families, who had their homes and beautiful grounds to the men in service and did much for their comfort and entertainment. Easter morning the service in charge of the Chaplain Stewart was a beautiful and the Casino marvelous in its gala array of Easter lilies and spring blossoms.
