

No Sudden Decision "But the outbreak of the war," the reply says, "was no sudden decision taken in a difficult crisis. It was the logical outcome of a policy of domination, aggression and war followed by Germany for decades. Hypnotized by Bismarck's spirit of blood and iron, Washington, June 17. — President Wilson, facing a divided Senate, has decided to carry his fight for ratifi-cation of the League of Nations cov-enant directly to the people in a country-wide speaking tour. He ex-pects to begin the trip as soon as he returns from Paris. The President's decision was 're-the Senate, in advance of signing the speaker and Son Movement'' as the subject of the Salutatory oration. It is said the problem is largely one of statis-tics, of which the powers have-re-ceived but one side. Germany is invited to poduce evidence which will accelerate final decision.
