The Annual Report of the Hon. James Pollock, Director of the Mint of the United States in Philadelphia, for the fiscal year ending on the last day of June, 1861, has just been printed.

In no former year was a larger amount of bullion received and coined at the Mint. The total deposits of bullion, received at the Mint and its branches, in the year 1860-61, amounted in value to \$121,504,961; deducting the re-deposits of bullion or bars made at one institution and deposits at another, for coinage, the total is \$72,146,571.

In this period of twelve months the total coinage of nickel cents was in value \$101,000; the whole amount--gold, silver, and nickel--amounted to \$83,093,767; the number of pieces of all denominations of coin, was 23,724,943.

A large amount of the gold deposited at the Mint, was the product of the mines of the United States. From this source was received \$34,216,859 in gold, and \$610,911 in silver.
