Death of Hon. Owen Lovejoy.

This champion of Freedom is no more. He died in Brooklyn, N. Y., at midnight on Saturday last. He was born in Kennebec county, Maine, and educated at Bowdoin College. After working his way through college, he studied theology, and settled over the Congregational Church at Princeton, Illinois. His Congressional career was marked by a passage of arms between himself and Roger A. Pryor, of Va., which led to the Potter-Pryor affair. He enjoyed a great popularity at his home in Illinois; was honest, fearless, amiable, and in private life irreproachable. His abolition views were greatly intensified by the butchery of his brother, Rev. E. P. Lovejoy, editor of an anti-slavery paper at Alton, Ill., at the hands of a pro-slavery mob in 1837.

General Bounty Bill.

AN ACT relating to the payment of bounties to volunteers.

TUESDAY, March 29.

Last evening, after the H. R. had done some business, Rev. J. R. Warner, of Gettysburg, gave, in the House, a most deeply interesting History of the Three Days' Fight on that most memorable field.

I had time to hear only the close, which was Webster's declaration, "Liberty and Union, now and for ever, one and inseparable."

A bill (348) passed the Senate to incorporate the White Deer railroad company—to have a capital of \$200,000 at \$50 each, with power to increase—to build a railroad from a suitable point near Milton in Northumberland county to the mouth of Jew's Run in Center county, with the right to connect with any railroad in Center or Clinton county—five years to commence, and ten years to finish the road—Sam'l Watson, Thomas Quay, George Bressler Jr., Wm. Myers, David Mart, Wm. A. Simpson, Joel Kastetter, Gen. Aschenbach, and Wm. P. Berry, commissioners to proceed.

WEDNESDAY, March 30.

stones, or supervisors of any township, or the corporate authorities of any city, ward, or borough shall be paid over to the treasurer of said city, ward, borough or township, or when such officer does not exist, to a person duly appointed by said authorities of said township, city, ward or borough, who, upon giving sufficient bond, for the faithful performance of his duties, shall proceed to pay to such persons, in the manner directed by the tenth section of this act; and shall be allowed the same percentage as is allowed to the county treasurer, by the tenth section of this act: *Provided*, That the compensation allowed to any collector of taxes, under this act, shall not exceed two per centum.

Sec. 12. That in case any veteran soldiers, who have re-enlisted, and have not been credited to any specific locality, shall hereafter be credited on the present draft, to the locality from whence they originally volunteered, such veterans shall be paid by the local authorities whose duty it is to pay bounties, such bounty as under the provisions of this act, shall be paid to volunteers from said locality.

Sec. 13. That if any soldier, or non-commissioned officer or private, who would have been entitled to receive the said bounty, shall have died before receiving the money, the proper authorities shall pay the same to such person or persons, as by the laws of the United States would be entitled to receive the bounty of deceased soldiers.

Sec. 14. That all receipts of the receipts and expenditures of the bounty fund, arising from any taxes that have been assessed, or that may be assessed for the purpose, so abundant, shall be allotted in like manner as other county, township, city, borough, or school district accounts are audited.

Sec. 15. All bonds, warrants, certificates of indebtedness or loans issued, or to be issued, by such commissioners, or contractors, of any township, or corporation authorities of any city, ward or borough, or by any authority of every kind, shall be payable at such time and place as may be agreed upon, and to levy such taxes as may be necessary to meet the payment of the principal and interest of said bonds, warrants and certificates, as the same shall become due; which taxes and levies shall be assessed, and collected, as other county, city, ward, borough, or township taxes are assessed, levied, and collected: *Provided*, That in all cases of non-commissioned officer or private, or for having or having been discharged, or for desertion, or for conviction of any offense, or for being a member
