Mr. Cowan's Position. We have now before us Mr. Cowan's speech in full, as published in the Congressional Globe...

1. The secessionists, who had gone away and established a "new Government, called the Confederate States."

2. There was a second party, who denied the right of secession, and who were determined to defend the right under the constitution...

3. There was another party, who denying the right of secession, and admitting the right of coercion, yet thought it inexpedient to use force to restore the Union...

4. There was a fourth party, to which Mr. Cowan said he had the honor to belong, which was about to assume the reins of government, to endeavor if possible to rescue the country from its difficulties, coerce rebellion and punish treason.

Mr. Cowan places Mr. Stanton in the third class, opposed to secession, opposed to Buchanan's theory, but opposed to coercion, as only tending to widen the breach...

Mr. Cowan thanks—"If that was so, was he (Mr. Stanton) justified in communicating with the Chief of the Government?" This question is answered as follows—"I think that is a fair question, because, if there was no war, and if there was to be no war, then this communication was innocent enough."

To our mind, this whole argument is inconclusive. It is a strained apology for such treason. Never Mr. Stanton may have thought, in the charitable estimation of Mr. Cowan, yet when we pass in review the circumstances of that case, we are driven to no other conclusion than that there was to be war in the fall of 1861...
