We cannot give, in consequence of the prohibition of the Secretary of War, any of the intelligence we have received of military movements which do not come to us by telegraph. It is, however, in some important and immediate military movements of a temporary character. The rebels have certainly been much more fortunate than we in keeping their military operations out of sight, and in this instance it is not probable that they have the advantage of us in the campaign. It is generally believed that it cannot be long before we shall have the opportunity of our operations on the Atlantic coast, still less is it likely to apply to the movement of our great Western army, now victoriously advancing through Tennessee to the Gulf States.
