### FROM THE GRAND ARMY OF TENNESSEE.

**The Pea Ridge Reconnoissance in Force.**

Camp Smith, April 24, 1862.

General Halleck is evidently determined that the rebel army should not be allowed to grow under his feet. This morning he ordered a reconnoissance to be made of the Pea Ridge road to Corinth. Early in the morning a party of the division of Gen. McCook, consisting of the regiments of Gen. Johnson, Stansbury, the batteries of Capt. Terrell, and the 1st and 2nd Kentucky Cavalry, with a regular army, took up their line of march on the Pea Ridge road, with three days' rations and a full complement of arms and accoutrements. The command of Major King, the 25th Ohio, led the reconnoissance, and was followed by the 1st and 2nd Kentucky Cavalry, the batteries of Capt. Terrell, and the 1st and 2nd Kentucky Cavalry.

### THE CASE OF GEN. STONE—MESSAGE FROM THE PRESIDENT.
