Disaster at Vicksburg. General Sherman has sustained a terrible reverse at Vicksburg, with a deplorable loss of life. Grant, by retiring, left Rosecrans to bear the shock of the concentrated rebels, a shock which nothing but consummate skill and valor prevented from being a fearful disaster, and the smoke of that terrible battle had hardly cleared away until another army, with which it was his imperative duty to cooperate, is defeated.

It is more than probable that some miserable person, jealous of the fame which attended the failure of the Pope campaign, and which forced Fremont out of the service.

So says the Louisville Journal, near the close of a long article, which was intended to be an argument as strong as could be made against the Proclamation of Freedom. But we are sorry to see such a paper as the Journal engaged in a cause so indefensible, in the absence of logic, it has to resort to slanders which, in the hands of the Journal, are as contemptible as they are untrue.
