PROCLAMATION.

There is reason to believe that an armed expedition is about to be fitted out in the United States, with an intention to invade the Island of Cuba, or some of the Provinces of Mexico.

The best information which the Executive has been able to obtain, points to the Island of Cuba as the object of this expedition. It is the duty of this Government to observe the faith of Treaties and to prevent any aggression by its citizens against the territories of friendly States.

Given under my hand, the 11th day of August, in the year of our Lord one thousand eight hundred and ninety-two, and of the Independence of the United States the 45th.

The Republic says that the above Proclamation was received yesterday at the Department of State, in communication from the President, at Harrisburg.

Information has been received in Harrisburg from the Government, to the effect that bodies of men were in the course of being levied, and drilled in the States of New York, New Jersey, and Pennsylvania.
