The Bowling Championship.

Important Decision.

The decision rendered on Monday in the Supreme Court at Philadelphia in the case of Fuzikowski & Son vs. Thomas Wallace, is of great importance. The question involved in the case was whether the lending of money at interest, and the receipt of a sufficient sum, could evade the law limiting the rate of interest six per cent. The plaintiff loaned the defendant in money, and in a collection therewith, left a bill of exchange, on which the lands were mortgaged for the charge of six per cent, which the jury found to amount to sixteen thousand dollars. The court however entered judgment for the defendant, and the cause was remitted to the court of common pleas for a new trial.

The case was argued in Philadelphia before the Supreme Court, by Gen. P. Hamilton, Esq., for the defendant, and by Hon. John C. Knox and Mr. T. C. Jones, for the plaintiff. There was no objection to it, sufficient proof that he was satisfied.
