Doings on the Fourth.

The Temperance Celebration at the Camp Ground.—Among the many celebrations and social parties held on the Fourth, the largest and most enthusiastic was that of the Washington T. A. Society, on the Camp Meeting Ground, W. St. place, near the six mile ferry. The gathering was not so large as anticipated, owing to similar celebrations got up by other branches of the Washingtonians. From one thousand to fifteen hundred persons were present, and all seemed to enter deeply into the spirit of the cause which called them together.

Layng, Esq. took the stand and delivered a short speech, which had a good effect and was listened to attentively.

The Choir sang again. Mr. Elder then appeared with a new Pledge Book, and called upon all to "come up to the troug' now."

The hour of one having arrived a recess was announced by the President of the day, when all who felt hungry retired to a table well supplied with the good things of the season.

After dinner, the drums sounded, and the multitude were soon re-assembled. James M. Cunningham, Esq., of Beaver was the first speaker on the stand. He delivered a speech, rich in sentiment and humor, which was received with frequent bursts of laughter and applause.

After another song, and the transaction of some business, those who belonged to the city repaired to the river, when they embarked upon the Moxahala, and other boats, bound for their homes, highly pleased with the day's proceedings.
