A magnificent hydraulic work exceeding even in extent the cost of the Croton works of N. Y. is now in progress in France with the view of affording abundant supplies of pure water to the city of Marseilles.

It is under the able direction of M. de la Roche that the canal that is to supply Marseilles will derive its waters from the Durance, near to the suspension bridge at Pertuis, and this will be conducted by open cuttings and tunneling for a distance of 51 miles, through the most mountainous and difficult country, until it reaches the arid territory of Marseilles, where it will be stored for the supply of the city.

Three chains of limestone mountains are already pierced by the ten miles of tunnels which are required to conduct this stream and aqueduct, which is estimated to cost the city of Marseilles about \$1,000,000. This has thrown the balance of trade against us, and the shipment of specie to the coast.

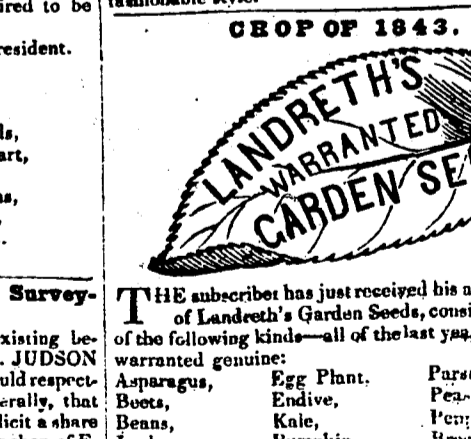
