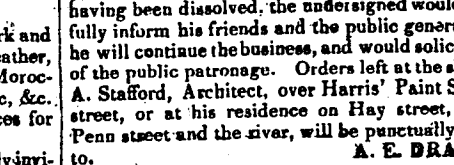


Illustration of a man in a suit, possibly a merchant or professional.

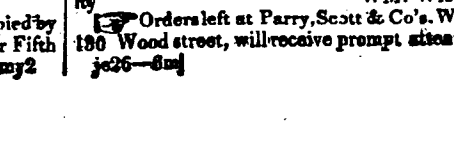


Illustration of a man in a suit, possibly a merchant or professional.

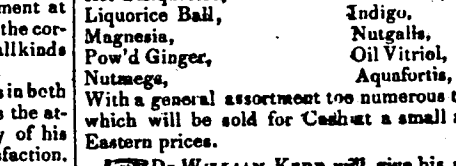


Illustration of a man in a suit, possibly a merchant or professional.

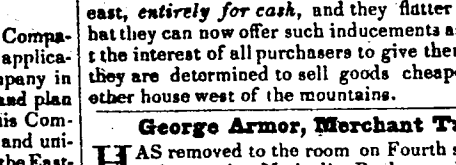


Illustration of a man in a suit, possibly a merchant or professional.

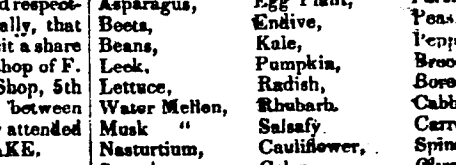


Illustration of a man in a suit, possibly a merchant or professional.

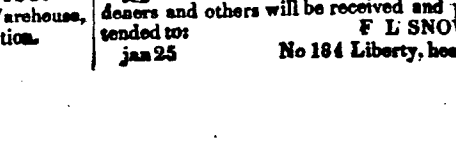
