His clothes (having none belonging to the United States) cannot be minutely described. He had on a light grey long coat with large gut buttons, a pair of coarse Home-made tow trousers, cross-armed, and a pair of half boots, very short and old.

It is earnestly hoped that all citizens favorable to the interests of their country, will make use of some exertions to ensure his apprehension, as every recent desertion appears purposely to defraud government. There are now upwards of one thousand deserters running at large, so that every suspicious character ought to be taken up and strictly examined.
