The cans and jars are constructed with a chanpel around the mouth, near the top, into which the cover fits loosely. This channel is filled with a very adhesive cement, prepared for the purpose and allowed to harden. In order to seal the sel hermetically, it is only necessary to heat the cover slightly, and press it into place. It may be opened with as much case as it is closed, by slightly warming the top. The ordinary tin cans, used for the same purpose for which this is intended, cannot be closed, as is well known without the aid of a tinner; are difficult to open, and are generally so much injured in opening as to be useless for future service.
