WASHINGTON, Monday 3 p. m., May 27.—The reports sent abroad, of the attack on and capture of Sewell's Point on Friday, and the taking of Norfolk, was a hoax.

A messenger who has just arrived from the Virginia side, reports that the 1st, 2d, 3d and 4th Regiments of New Jersey are still occupied in throwing up earthworks a mile beyond Long Bridge.

The Rebel Congress reduced the duty on silks, satins, jewelry, and other articles of sumptuous luxury and frippery, in order to please the people of France, and others, who produce and manufacture such articles.

Fortress Monroe, May 27, 5 p. m.—Gen. Butler, accompanied by acting Adjutant General Talmage and his aids, made a dashing reconnaissance several miles between the James' and York Rivers.

Three fugitives, the property of Col. Mallory, commander of the rebel forces near Hampton, were brought in by our picket guard, yesterday.
