#### PROCLAMATION OF GENERAL JACKSON, Addressed to the negroes of Louisiana, when

New Orleans was threatened by the British in 1814.

HEADQUARTERS, 7TH MILITARY DISTRICT ( MOBILE, September 21, 1814. To the free colored inhabitants of Louisiana :

Through a mistaken policy you have been heretofore deprived of a participation in the glorious struggle for national rights in which our country is engaged. This no longer shall exist.

As sons of freedom, you are now called upon to detend our most inestimable blessing. As Americans, your country looks with confidence to her adopted children for a valor-ous support, as a faithful return for the acvantages enjoyed under her mild and equita. ble government. As fathers, husbands, and brothers, you are summoned to rally around the standard of the eagle to defend all which is dear in existence.

Your country, although calling for your exertions, does not wish you to engage in her cause without renumerating you for the servi ces rendered. Your intelligent minds are not to be led away by false representations. Your love of honor would cause you to despise the man who should attemt to deceive you. With the sincerity of a soldier, and the language of truth, I address you.

To every noble-hearted freemen of color volunteering to serve during the present con-test with Great Britain, and no longer, there will be paid the same bounty, in money as lands, now received by the white soldiers the United States, namely, \$124 in mone and one hundred and sixty acres of land. T non-commissioned officers and privates w also be entitled to the same monthly pay, d ly rations, and clothes, furnished to a American soldier.

On enrolling' yourselves to companies, m jor general commanding will select officers i your government from your white fellow cit zens. Your non-commissioned officers w be appointed from among yourselves.

Due regard will be paid to the feelings freemen and soldiers. You will not, by bein associated with white men in the same cor be exposed to improper comparison of unju sarcasm. As a distinct, independent batta ion or regiment, pursuing the path of glor you will, undivided, receive the applause an gratitude of your countrymen.

To assure you of the sincerity of my inte tions, and my anxiety to engage your invalu ble services to our country, I have commu cated my wishes to the Governor of Loui ana, who is fully informed as to the manner enrollments, and will give you every necess ry information on the subject of this address
