The Union State Convention of California has pronounced in favor of the re-election of President Lincoln.

The Maine Legislature has passed a Constitutional amendment allowing the soldiers of that State to vote.

The majority for the Constitutional amendment, in the State of New York, allowing soldiers to vote, is 110,710.

The late John C. Rives of Washington was a practical patriot. He gave in the early part of the war \$12,000 to recruit a regiment.

John C. Rives, for thirty-five years proprietor and publisher of the Congressional Globe, died at his residence near Bladensburg, on April 10th.

Mad dogs are said to be quite plenty in Cumberland county, just now. We have none of that sort of "reptiles" here, but we frequently see mad "Copperheads."

A horse costs two thousand dollars in Richmond. A Confederate soldier's pay is, we believe, fifteen dollars a month, Confederate money. So a soldier would have to serve only between eleven and twelve years to get "money" enough to buy a horse.

The State Senate has added a section to the appropriation bill providing a sinking fund and tax of ten dollars on each and every incorporation bill, to provide for the erection of additional wings to the Capitol at Harrisburg, which kills the movement for its removal to Philadelphia.

Both branches of the Legislature have passed the bill providing for a special election throughout the State on the first day in August next, at which the people shall decide whether the proposed amendment to the Constitution permitting soldiers to vote shall be adopted. The Legislature is to meet on the 23rd day of August to receive the returns.

The Committee appointed by Congress, last month, to investigate certain alleged malpractices in the New York Custom House, have closed up their business and returned to Washington. Many witnesses were examined, and much testimony, some of it said to be of a startling nature, was elicited, especially in regard to the operations of the blockade runners. In due time the Committee will report, and meanwhile not a few individuals, who have been in the habit of making proclamation of their loyalty on all possible public occasions, would do well to stand under if they do not wish to be hurt.

The Warren Mail—Mr. Cowart says that at the late great meeting of the Christian Commission in that city, one speaker from Liberty prison, Richmond, enjoined it upon President Lincoln, who was in attendance, as the anxious wish of our brave boys confined in rebel workhouses dungeons, that he should be as firm as steel, not yielding an inch to the rebellion until its cause should be crushed forever, even though they perished. The writer adds:

"The great audience were in tears and the strong, care-worn, pale-faced President of the nation who sat in front, bowed his head and wept like a woman. There is no man in all this great hearted nation who feels the soldier's hard fate with a keener and more enduring pain than President Lincoln."
