HARRISBURG, May 1, 1866.—In obedience to the authority vested in me by a resolution adopted by the Convention of Soldiers, held in this city, on the 5th day of March, 1866, I do hereby request the honorably discharged soldiers of Pennsylvania to meet in their respective Legislative districts, and elect delegates, not exceeding five in number, to represent their district in a Soldiers' Convention, to be held in the city of Pittsburgh, on Tuesday, the fifth of June next, at ten o'clock A. M.

Where any Representative district comprises more than one county, the manner of electing the delegates is respectfully referred to the soldiers of the district, for such conference as will result in a fair representation of each county.

Citizens who have borne arms in defense of the nation against treason have especial interest in the purposes of the Convention, and it is desirable that as full a representation of the brave defenders of the country as possible should be secured on this occasion.

Gov. Hawley was inaugurated Governor of Connecticut, on May 2d. In his address, he took strong grounds in favor of negro suffrage, and advised that it again be submitted to a vote of the people of the State. With reference to Federal relations, he supports the measures advocated and upheld by the majority in Congress.

The War Department has issued a general order to the effect that the President has ordered that hereafter whenever offenses are committed by civilians, they are to be tried where civil tribunals are in existence to try them. This order is not applicable to camp followers, etc.

Gen. Meade has withdrawn the regular troops from the Maine border. It is reported that a United States gunboat has taken arms from a Fenian schooner, supposed to be a privateer.

POLITICAL ITEMS.

A Washington dispatch says the President has ordered pardons to be issued to all North Carolinians who had applications or petitions on file, and directed them to be completed and sent to the petitioners. This includes all the petitions from that State on file in the office of the Attorney General—several hundred in number.

The feeling is growing in Congress that, so far as the white population is concerned, the desirable point to reach is the exclusion of the rebel leaders from office, and permitting the masses to vote.

Maj. Gen. G. M. Dodge, is proposed as a candidate for Congress, by the more decided Republicans, in the 5th Iowa district. Hon. John A. Kasson is the present representative.

The nomination of Frank Blair as Collector of Internal Revenue, at St. Louis, was rejected by the Senate, in executive session, by a vote of 8 for to 21 against it.

The Representation of the Southern States in Congress, in accordance with the proposed amendment, would be fifty—a reduction of twenty-five.

It is understood that the Government fully approves of the course of Commodore Rodgers at the Spanish bombardment of Valparaiso.

It is stated that Mr. Stanton favors the Congressional plan of reconstruction, excepting the clause disfranchising the rebel masses until 1870.

Rev. J. H. Ryland, has been appointed collector of internal revenue in the Congressional district in Maryland, represented by Harris.

The report of the Committee on Reconstruction ignores the question of suffrage—leaving that entirely with the several States.

Hon. D. A. Finney, is a candidate for Congressional nomination, in Crawford county, at the Union primary election.

The Republicans of Somerset county have made their local nominations. Gen. Koontz is their choice for Congress.

Mrs. Jefferson Davis arrived at Fortress Monroe, on May 3d, direct from Montreal.

Steel Rails are being adopted by the roads of the United States, as the cheapest, safest and most economical, in the wear of locomotives and cars, that can possibly be used. They cost, of course, more than the ordinary iron rail, but they wear ten times as long, and are superior in all other respects. It is understood that the leading roads in this State are either making contracts for a supply of steel rails, or they are superseding the old iron with the steel rail as fast as they can be manufactured.

The first conviction for treason which has ever taken place in Tennessee has been adjudicated at Danbridge, Jefferson county. The man's name is D. C. Williams, jr. His punishment is fixed at 14 years in the State Penitentiary.

Congress has decided that none of the forts, arsenals, military posts or naval stations belonging to the United States shall bear the name of a disloyal personage, or in any way be used to perpetuate the memory of a traitor.

A Washington dispatch says that the yellow fever is raging on the gunboat Kearsage at Madeira, and six men had already died from the disease.

Taking the ballot from a rebel, says the Knoxville Whig, has the effect of extracting the sting from a bee. It renders him powerless for mischief.
