SEBIOUS ACCIDENT. -On Friday evening. July 20th, Mrs. O. B. Merrell, of this Borough, and her mother, Mrs. Nichols, and Mrs. Gaulin, met with a very serious accident, by being thrown from a carriage. The circumstances, as near as we can learn, are as follows: The ladies above named, had gone on a visit to some relatives, a number of miles in the country, in a two-horse carriage, in the morning. On their way home, in the evening, as they were coming down a hill, about two and a half miles from this place, the horses took fright at a stump on the side of the road and ran away. Mrs. Gaulin threw her child out of the back part of the carriage and then jumped out herself, without sustaining any damage, but the child was bruised a little. After the horses ran a short distance they kicked the front part off the carriage, when Mrs. Nichols and a small boy fell down at the heels of the horses-Mrs. Nichols receiving several severe bruises on the arm and shoulder, from which she suffered much, while the boy was but slightly hurt. The horses continuing on a short distance further ran the carriage against a stump, breaking it to pieces, and becoming detached left at the top of their speed. Here Mrs Merrell was thrown out, (with her little child, which escaped unhurt,) and when discovered was lying some fifteen feet ahead of the carriage in an unconscious condition. She was taken to Mr. Antes', near by, and medical aid summoned. Upon investigation it was found that she had received a severe cut near the right ear, and that her scull was slightly fractured. She was afterwards conveyed to her home, on a stretcher, by a number of our citizens, where she has been lying in a very critical condition ever since. She is, however, improving, and hopes are entertained of her speedy recov-
