THE KIDNEYS.

The kidneys are two in number, situated at the upper part of the loin, surrounded by fat, and consisting of three parts, viz: the anterior, the interior, and the exterior.

The anterior absorbs; the interior consists of tissnes or veins, which serve as a deposit for the urine and convey it to the exterior; the exterior is a conductor also, terminating in a single tube, and called the ureter; the ureters are connected with the bladder.

The bladder is composed of various overings or tissues, divided into parts, vis : the upper, the lower, the nervous, and the mucous. The upper expels the lower retains.
